Fee

Fee per participant (without VAT) is determined based on the following schedule:

- 1,100 USD if the participant registers and pays before or on 20-Dec-13;
- 1,350 USD if the participant registers and pays between 20-Dec-13 and 10-Mar-14.

The fee includes:

- interim tests;
- mock examination (+3 hours to the main course);
