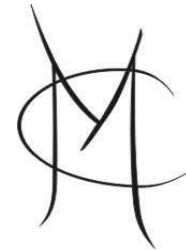

### **REQUIREMENTS FOR AUTHORS**

Please supply text of your report: in Microsoft WORD 97-2003 using Times New Roman 14, line spacing - 1,5, indention – 10 mm, all page margins – 25 mm. Please do not numerate pages. Do not use page break, section break and footnote function.

Put down title of your article – in the centre (in capital letters), in the left one paragraph: name author and supervisor's name (stress), the name of the organization.

Article includes minimum of graphical and table materials after your article's headline. All figures, pictures are grouped and in the text, have names under them. Tables have titles before them. There are and list of references at the end of article. Do not use foot and end notes; page and line breaks as well. This paper must be introduced at 3 full pages.
